### **>> The Polish Risk Management**

Association elected a new governing board at its general meeting last month. The new board will be led by **Rafal Rudnicki**, the current PolRisk president, who was re-elected to serve a three-year term. PolRisk members decided that the new board should sign a cooperation agreement with the Polish Institute of Directors, a non-profit organization that promote good corporate governance practice. Under the agreement, PolRisk will become an organization member of PID, and vice versa. PID is comprised of mostly directors and supervisory board members for Polish companies listed on the Warsaw Stock Exchange.
